the county staff recommendations for the County to participate in AB811, the State's recently passed legislation that allows municipalities to fund installation of energy-efficiency upgrades for commercial, residential and industrial buildings. As a result, energy efficiency improvements can be financed through property taxes over many years. For example, this will allow a homeowner to purchase solar panels, new windows and HVAC systems by amortizing the cost on to their property tax bill. The county will be making announcements in the future about how to participate in this program.

California Stewardship Exchange

On December 9th, County Supervisors Adam Hill, Frank Mecham and Mike Manchak attended a two-day meeting of the California Stewardship Exchange at Stanford University in Palo Alto. Sponsored by the Morgan Family Foundation, the project develops innovative regional solutions to California's most pressing economic, environmental, and community challenges. These solutions will require breakthrough innovation driven by a new generation of "civic entrepreneurs". The regions participating are San Diego, Fresno, Inland Empire, Los Angeles County, Silicon Valley, Sonoma County, Redwood Coast, Butte County, Sacramento and Sierra. As a result of this meeting, San Luis Obispo County is now a participant in this group to provide local input on statewide solutions.

Green Coast Innovation Zone

"This is believed to be the first such meeting ever of representatives from the tri-counties to address economic development for the region. Being focused on the promising green industry made it even more vital".

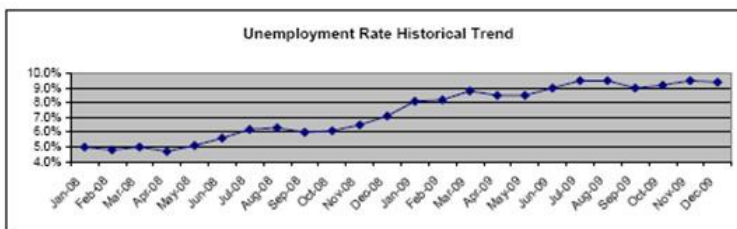

The unemployment rate in the San Luis Obispo County was 9.4 percent in December 2009, down from a revised 9.5 percent in November 2009, and above the year-ago estimate of 7.1 percent. This compares with an unadjusted unemployment rate of 12.1 percent for California and 9.7 percent for the nation during the same period.

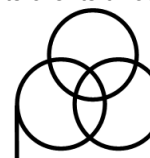
